## Register your interest for China European Marketplace

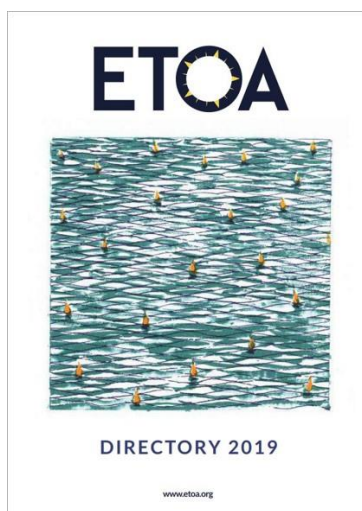

On the 29th May our CEO Tom Jenkins gave a keynote and spoke on a roundtable at HotelBeds MarketHub Europe Conference at Swissotel The Bosphorous. The Roundtable was on the general topic of shifting futures in the tourism industry and he discussed how the tourism industry can become more sustainable and critiques of some of the common misconceptions people have about the tourism sector's effect on the local environment of destinations and the global environment as a whole.

Later the same week he also joined a panel at the Asian Resilience Summit in Kathmandu on the topic of Maximizing Opportunities Found Within Cultural Diversity. 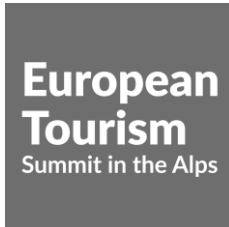

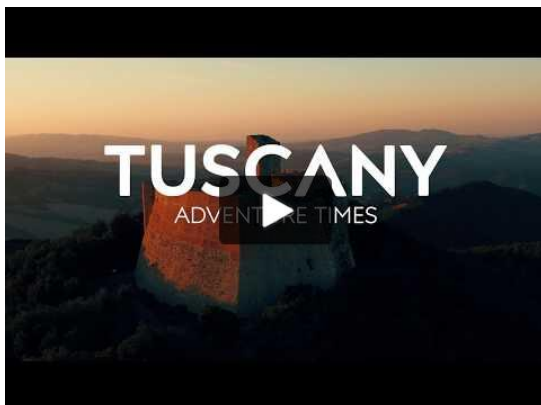
